## SO MUCH GOOD:



Over the past five years, Scotty's House has been able to serve 2,186 children. This is due in large part to the funds raised at the Great American Steak

Out. Scotty's House worked with our partner agencies to coordinate the investigation, prosecution, and treatment of these child abuse cases in order to lessen the trauma faced by the child and their family. As the only agency of its kind in the Brazos Valley, Scotty's House removes barriers to treatment and enhances criminal prosecution with support from our partners including Brazos Valley law enforcement, Child Protective Services, and the District Attorney's Offices.
