Ongoing Sponsorship Opportunities

- **Multi-Disciplinary Team (MDT) Sponsor (24 per year): \$250 each**
 - MDT is a critical component to the Child Advocacy Model. We work with law enforcement, Child Protective Services, the district attorney's office, and SANE nurses to coordinate the investigative process of child abuse cases. Each month (2x a month in Brazos County), we host MDT meetings in each county which all partners are involved in the investigation process of active cases meet and staff those cases. It's all about coordination and collaboration- ultimately to better serve child victims of abuse and neglect.
 - As an MDT Team Sponsor, your support will enable those meetings along with other outreach and education opportunities for our MDTs across the region. Your Company name will be included in the invite email to Brazos County MDT members and featured on our social media page the week of the meeting.
- **MAV Backpack Sponsor: \$24 for 5 MAV Backpacks**
 - Support will help purchase the items needed to create MAV Backpacks. When a child needs a forensic medical exam at a local hospital to make sure they are medically stable and to gather information and evidence for an investigation, a Scotty's House Medical Accompaniment Volunteer (MAV) is deployed with a MAV backpack in tow. MAVs meet the child and their family at the hospital and are there to provide information and support services; the MAV Backpack is stocked full of items to help them in that role. Backpacks include coloring books and activities, informational flyers for support services, plus a blanket and stuffed animal for the child to take home with them.
